What is a Charge Card?

A Charge Card is similar to a credit card as you can spend on it the same way as a credit card, but it has a monthly spending limit and requires that you pay the statement balance in full every month. Your Santander International Charge Card will be linked to a Gold Account in the same currency and each month the balance is due it will be automatically deducted from your Gold Account. You will therefore need to ensure that you have sufficient funds in your Gold Account every month to make the payment.

The Charge Card is available in a choice of Sterling, Euros or US dollars.

You can apply for a Charge Card if you are aged 18 years or over

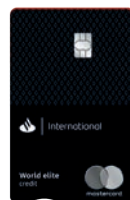
- You must hold a Gold Account with us in the same currency of the Charge Card

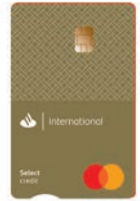

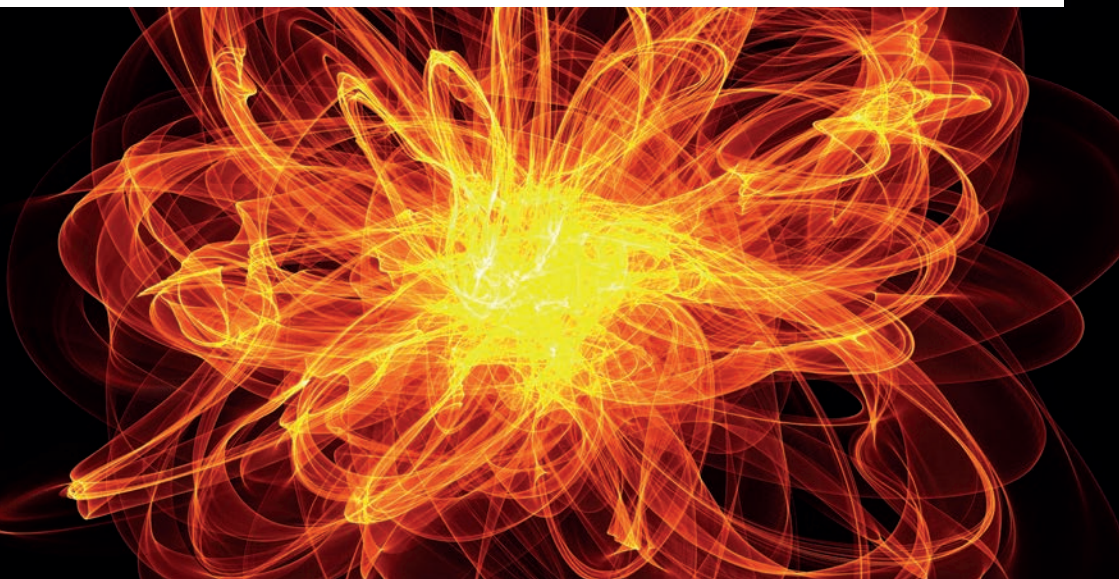

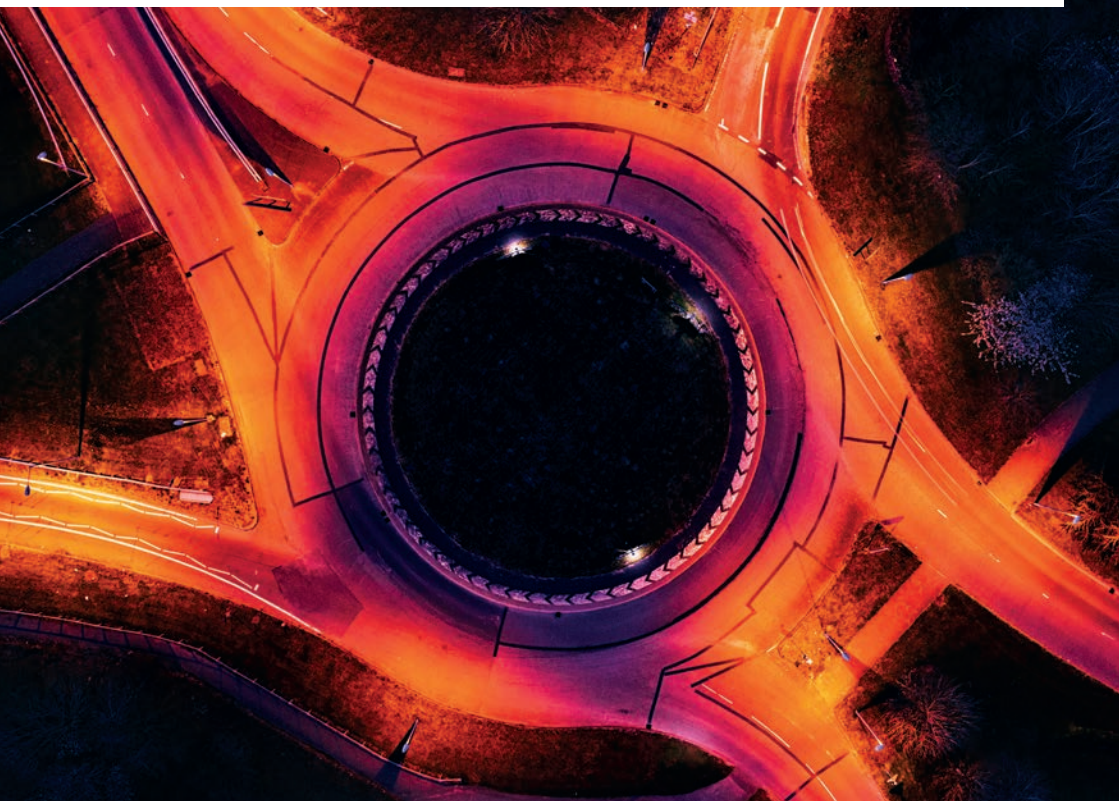
